## **NOTICE TO SCHOOL AUTHORITIES**

### ***Leaving Certificate Examination 2018***

#### ***Technology – Coursework***

The accompanying *Instructions to Candidates* provides clarification to all candidates of the procedures to be followed in the selection and execution of Student Coursework for **Technology**, Leaving Certificate Examination 2018.

In the interest of inter-candidate equity, it is required that each candidate submits a separate and distinct project for the purposes of assessment.

***The Coursework must be available for assessment by Friday 23<sup>rd</sup> March, 2018.***

When the coursework is completed it will be retained in the school and marked over a period of about a week or so in June 2018 by assistant examiners appointed by the Commission. The work of the assistant examiners will be monitored by a panel of external examiners appointed by the Commission.

#### **Storage of design tasks:**

On completion of the design task, school authorities should ensure that the finished artefact and design folder are kept in a safe place under lock and key until the examining process (including appeals) has concluded.

*The assistance of School Authorities and teachers of Technology in maintaining the integrity of the assessment process is very much appreciated by the State Examinations Commission.*
