Guidelines for Project Work

2. All project work must be executed in the school under the supervision of the Engineering teacher.
3. The Engineering teacher should monitor the progress of the candidates' project work on a regular basis and be in a position to validate the work on Form P. 2 which will issue to schools in February.
4. Any temporary support systems required by candidates for the operation of the projects (e.g. batteries, power supply units, pneumatics etc.) should be available, in good working order, with the projects concerned at the time of assessment.
5. Any special instruction regarding testing of projects should be contained in the folder being presented.
6. When the Project Work has been completed school authorities should ensure that all projects are kept in a safe place, under lock and key, until the examining commences.
