When the Design Tasks are completed they will be retained in the school and marked over the period of about a week in **June 2016** by examiners appointed by the Commission.

The Commission wishes to take this opportunity to remind schools of the following guidelines:

1. All Design Task work should be executed in the school under the supervision of the teacher.
2. Teachers should monitor the progress of the candidates' work on a regular basis.
3. Design Tasks submitted for assessment must be the candidates' **own unaided work**.
