- The assignment is common to Higher and Ordinary Levels.
- The date for completion of practical coursework is **22nd April 2022**.
- Candidates should note the 'General Information for Candidates' on pages two and three of this document.

# Textiles, Fashion and Design Elective Practical Coursework Assignment Brief, 2022

*Your clothes tell your story, they are part of who you are.*

Design and sketch an outfit that reflects your personality, something that you feel good in and will enjoy wearing.

Set out the design specifications for the outfit.

Make and evaluate **one** garment from the outfit. The garment must include **two** of the following processes:

- (i) a pocket
- (ii) appliqué or decorative stitching
- (iii) darts or shaping.

## General Information for Candidates

- Candidates selecting the Textiles, Fashion and Design elective are required to
  - conduct an investigation of the assignment following the design process
  - produce design sketches for an outfit based on the theme of the assignment
  - construct one garment from the outfit designed
  - present a design folder with information on analysis and research, implementation and evaluation.
- Details of the assessment criteria and mark weighting are included on page 4.
- The garment completed as part of the Textiles, Fashion and Design elective must
  - be textile based
  - include the processes specified in the assignment
  - include a clearly identifiable interpretation of the theme in the design of the garment
  - demonstrate competence in a range of textile skills that show progression from the skills developed in Junior Cycle Home Economics.
- The written support material submitted as part of the completed assignment should be presented in a folder. This design folder will be submitted for examination with the completed garment.
- The candidate will be required to include his/her examination number on the folder and on the completed garment.
- Candidates may only present individual work, group work is not acceptable.

- Candidates must carry out all aspects of their textiles coursework under the supervision of the Home Economics class teacher. If the coursework is not completed under the teacher's supervision, he/she will not be able to validate the work as being your own individual work when requested by the State Examinations Commission to do so.
- All work presented for examination (written and practical) must be the candidate's own individual work (verified by the candidate and the class teacher). Any secondary materials e.g. books, journals, web sites etc. used, must be acknowledged. Where there is evidence of collaboration in the recording of any aspect of an assignment, the marks for the assignment work presented will be disallowed.
- Where assignment work cannot be verified as the candidate's own individual work, the State Examinations Commission will take appropriate action. This may result in the work presented being deemed invalid and marks awarded in respect of it being discounted when determining the overall result.
- Any incidence of suspected copying, improper assistance from another party, plagiarism or procurement of work prepared by another party will be thoroughly investigated and candidates are liable to have penalties imposed as provided for in the *Rules and Programme for Secondary Schools*. The penalties include loss of the subject, to loss of the entire examination in all subjects, to being debarred from the Certificate Examinations in subsequent years.

There may be serious consequences for any other party involved in improperly assisting students as the Education Act 1998 provides for certain criminal offences in relation to the conduct of the examinations.

- Arrangements for the assessment of the design folders and completed garments together with dates for completion will be notified to schools by the State Examinations Commission.
- Teachers and the authorities of schools are familiar with the detailed requirements to ensure that project work is valid for examination purposes. Candidates should comply fully with all requests that they make that are designed to enable them certify that the work presented for examination is your own unaided work.

Remember responsibility for complying with the examination requirements rests with you the candidate. *If the above requirements are not followed your teacher and the school authority will have no choice but to bring this matter to the attention of the State Examinations Commission.*
