TO AUTHORITIES OF POST-PRIMARY SCHOOLS.

Schools are advised that the examining will be undertaken in the period **5th – 15th June** (inclusive) by a panel of visiting examiners. The work of the assistant examiners will be monitored by advising examiners during the same period.

Assistant examiners will contact schools in advance regarding the date(s) of the proposed visits.

To facilitate the examiners school authorities are requested to arrange for candidates to lay out their work, before classes break up, under the supervision of the Art teacher(s).

The work should be laid out in numerical order. Ordinary Level separate from Higher Level, in a suitable secure room(s).

Please make sure the Form P2 is made available for the Examiner

In laying out the work it is suggested that, in the case of each candidate, the 3D work should be placed on top of the plastic envelope containing the candidate's 2D work.

The Art teacher's presence is not required while marking is in progress in the Centre.

On completion of the examining the candidates' work should be retained in a safe place under lock and key, **until after the closing date for applying for a review of Junior Certificate results.** At that stage the projects may be returned to candidates **except** in the case of those candidates under review. In such cases it will be necessary to securely retain the projects until any review is complete and the outcome advised to the school.

Ba choir an obair a leagadh amach in ord uimhriúil. Gnáthleibhéal ar deighilt ó Ardleibhéal, i seomra(i) oiriúnach(a) agus iad slán.

I gcás gach iarrthóra moltar, agus an obair á leagan amach, an obair 3T a chur ar bharr an chlúdaigh phláistigh ina bhfuil obair 2T an iarrthóra.

Ní gá don mhúinteoir Ealaíne a bheith i láthair fad a bhíonn an mharcáil ar siúl san Ionad.

Ar chríochnú an scrúdaitheoireacht ba chóir obair an iarrthóra a choimeád faoi ghlas in áit shábháilte **go dtí in dhiaidh an dáta deiridh d'athbhreithniú torthaí an Teastais Shóisearaigh**. Ag an tráth san is féidir na tionscadail a thabhairt ar ais d'iarrthóirí ach amháin i gcás na n-iarrthóirí úd ina bhfuil achumharc curtha isteach. I gcásanna dá leithéid beidh sé riachtanach na tionscadail a choimeád go sábháilte go dtí go mbeidh an t-athbhreithniú curtha i gcrích agus an toradh curtha in iúl don scoil.
